

# PIMCO TRENDS Managed Futures Strategy Fund

## PERFORMANCE SUMMARY

The PIMCO TRENDS Managed Futures Strategy Fund returned -0.97% (Institutional, Accumulation shares net of fees) in January. Year-to-date the Fund has returned -0.97% (Institutional, Accumulation shares net of fees).

The portfolio was down overall in January, driven by reversals in global interest rate and currency markets. Losses were partially mitigated by gains from select commodity and equity positioning. Global rates reversed prior trends and sold off in January amid a hawkish Fed signal that also drove a strengthening US dollar. Global equities continued to rise on a resilient economy while commodity prices were mixed. The MSCI World Equity index returned +1.2%, the Bloomberg Global Aggregate Index was down -1.4%, the Bloomberg Commodity Index declined -0.1%, and the Bloomberg Dollar Spot Index rose +1.9%.

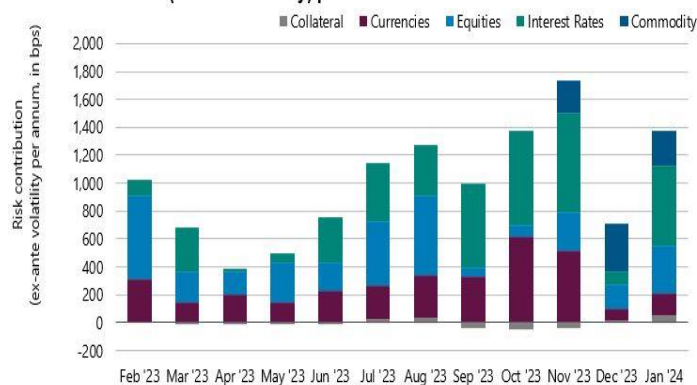

## MONTH IN REVIEW

Global sovereign yields rose and the US dollar strengthened in response to statements from Federal Reserve officials suggesting that interest cuts may begin later than current market expectations. Developed market equities were up on optimistic economic data while emerging market equities declined. Overall commodity prices were mixed as gains in energy and livestock were offset by losses in grains and metals. The portfolio generated net negative returns over the month as rising yields, strengthening USD, and declining emerging market equities detracted, through long exposure to global duration, currencies (excl. LatAm FX) vs. USD, and LatAm equity indices. Meanwhile, contributors were primarily driven by short exposure to EM APAC equity indices, agricultural commodities, and long positions in LatAm FX vs. USD.

## PORTFOLIO POSITIONING

The overall volatility decreased in January as the portfolio reduced its long exposure to interest rates and reoriented to an overall long USD exposure. Meanwhile, the portfolio maintained an overall long equity and short commodity exposure.

Over the long-run, the portfolio continues to deliver low correlations to underlying asset classes. Since inception (June 30, 2015) correlations:

- MSCI World Equity Index: -0.26,
- Bloomberg Global Aggregate Index -0.14,
- Bloomberg Commodity Index -0.15,
- Bloomberg Dollar Spot Index 0.19.

## OUTLOOK AND STRATEGY

The fund pursues a disciplined approach to trend following, providing exposure to global markets including currencies, equities, interest rates and commodities\*. The fund uses proprietary quantitative models that are designed to identify price trends through both long positions that seek to benefit from rising prices and short positions that seek to benefit from falling prices. The fund is exposed to a wide range of global markets across asset classes, but seeks low long-term correlations to any particular asset class through its ability to dynamically take both long and short positions. Accordingly, market environments with persistently high volatility and persistent trends may be more favorable for the fund than market environments characterized by sharp trend reversals or persistently low market volatility without persistent trends.

Importantly, the dynamic nature of the strategy allows the portfolio to adapt quickly to changing market conditions.

\*Starting in October 2023, the GIS TRENDS portfolio expanded its investment universe to include commodities consistent with its investment policy.
